### **Sustainability Indicators**

Responding to the data from the public meetings, the Local Authority agreed Sustainability Indicators with the partner organisations over a series of meetings.

#### What are Sustainability Indicators?

Indicators are measurements that tell us how we are performing, the condition of something we value, or sometimes the pressures that affects it.

The intention is to produce a picture of measurable facts about our communities and their environment that will be published each year in the Local Authority's Annual Report and supplied to every home

This process of informing everyone with regularly up-to-date facts enables them to see which problems are improving, those that are stubbornly not moving and also those deteriorating. This information will empower local people and local organisations to make better choices based on local facts rather than perception.

The Sustainability Indicators that have been chosen by the relevant partner organisations to illustrate the state of an issue, ideally relate directly to the main issues discussed by the community at their meetings.

### It is on these Indicators that we would welcome your views.

Please bear in mind that we can't always get the data on the precise element we may wish to measure, but may sometimes have to settle for a pressure that affects it.

The UK National set of Sustainability Indicators contain 147 core indicators, with 15 of these selected as Headline Indicators (see Appendix III). The Welsh Assembly have published 35 additional indicators. If an indicator proposed for Tawe Afan Nedd appears on the UK list or the Welsh list you will find a (UK) or (W) in brackets after it, (H) means it is a Headline indicator for the UK. However, the majority of indicators originated locally from community raised issues or local agencies` priorities.

### Positive Local Initiatives aimed to influence the indicators on Waste and Natural Resources

In 2003 the new Waste to Energy Plant at Jersey Marine will begin taking our domestic waste and recycling more than 60% of it. This does not mean we can forget about our waste as some 30% of the remaining ash will continue to go to landfill, so we still need to try to reduce our waste by buying less packaging and composting at home. Unwanted items of furniture are collected by the Furniture Initiative and passed to families on low incomes.

HEES grants are available to reduce the cost of energy efficiency measures in the home.

Awel Aman Tawe are looking into the feasibility of a community run wind farm in the upper Aman Valley, putting its profits back into the community, local people will be voting on the project as part of a comprehensive community consultation.




Sustainable Tourism initiatives such as the National Trust halving their admission charges to those who arrive by public transport or bicycle. The local Community Development



Glanymor Primary School has four separate "Walking Buses" travelling to the school daily made up of 20 parents and over 100 pupils taking part.

The Road Safety Unit working with Community Police Officers are endeavouring to train over 75% of Year 6 pupils to Cycling Proficiency each summer, in order to encourage safe cycling to schools.

One-Stop-Shop offices have been set up in Pontardawe to enable local residents to access the main Council services without travelling to the main Civic Offices in Neath and Port Talbot.

Both of the Shopmobility schemes in Neath and Port Talbot are proving very popular and successful.
